The drinks will feature a selection of alcoholic and non-alcoholic cocktails and specialist beers from the region as well as showcasing wonderful Lebanese wines from Ksara, Comptoir Group's long-standing partner supplying Lebanese wines. Comptoir Libanais, Southbank Centre will be a true reflection of the Middle Eastern culture, creating a vibrant and authentic atmosphere, all delivered in the true spirit of generous hospitality.

"We are proud to be a part of the fabric of London's diverse culinary landscape as we open the doors of another new restaurant, this time in London's South Bank.
